#### 1. HOW TO ENTER

- a. These rules govern the MS Metro 9/7 ("Contest"), which is being conducted by KZZO-FM ("Station"). The Contest begins on Monday, September 7, 2020 and ends on Monday, September 14, 2020. ("Contest Dates"). Entrants, as defined below, may enter via texting ("on-air") or online only.
- b. To enter the Contest, the person entering the Contest ("Entrant") may enter by text message or online beginning on Monday, September 7, 2020 at 6:50 a.m. (PDT) and ending on Friday, September 11, 2020 at 7:50 a.m. (PDT) ("Entry Period"), within thirty (30) minutes of hearing the announced Keyword, which will be announced on-air at 7:20 a.m. (PDT) each weekday during the Entry Period.
  - i. To enter via text message, tune in to the Station each weekday beginning on Monday, September 7, 2020 at 6:50 a.m. (PDT) and ending on Friday, September 11, 2020 at 7:50 p.m. (PDT) during these dates and listen for the on-air personality to announce the cue to text. Upon hearing the cue to text, listeners must text the Keyword announced on-air to 21005 within the time period specified to enter the Contest. Only one (1) entry per Keyword per Entrant is permitted. By texting to enter the Contest, the Entrant consents to receive automated messages about the Contest on his or her cell phone. Standard message and data rates may apply. The frequency of automated message(s) that an Entrant may receive after entering the Contest may vary. If an Entrant wishes to stop receiving text messages, he or she can text STOP to cancel such messages.
  - ii. Terms are available at the Station's Terms of Use. Station assumes no responsibility for charges incurred for text messaging, including, without limitation, any text messages or Contest notices from the Station. To be

eligible to win, Entrants in the Contest must provide all information requested including Entrant's full name, complete address (including zip code), day and evening phone numbers, email address, and date of birth to verify eligibility. P.O. Boxes are not permitted as addresses.

- iii. To enter the Contest online, visit [now100fm.com](http://now100fm.com) and follow the links and instructions, include the short code 21005, the Keyword announced on-air on the Station, and complete and submit the online entry form during the Entry Period outlined above. Online Entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy and Terms of Use. Only one (1) entry per Keyword per Entrant is permitted. Multiple Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Station. Online Entrants will also be required to listen to the Station during the times listed above for the Keyword and short code and must submit them in the online entry form.
- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.
- e. Only one (1) entry per Entrant is permitted regardless of the method of entry. There will be up to a total of five (5) qualifying prize winners ("Qualifying Prize Winner") and one (1) grand prize winner ("Grand Prize Winner") selected in the Contest.
- f. All text message and online entries must be received by the end of the Entry Period.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of California, eighteen (18) years of age or older, and who reside in the Sacramento Metropolitan area as defined by Nielsen (Yolo, Sacramento, Sutter, Nevada, Placer, and El Dorado Counties). Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (i) any employees (i.e., full-time, part-time and/or temporary employees) of the Station,

Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

- c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the thirty (30) days prior to entering the current Contest are not eligible to participate. Persons who have won a prize valued between \$101 and \$499 in the ninety (90) days prior to entering the current Contest are not eligible to participate. Persons who have won a prize valued between \$500 and \$999 in the six (6) months prior to entering the current Contest are not eligible to participate. Persons who have won a prize valued at \$1,000 or more in the twelve (12) months prior to entering the current Contest are not eligible to participate. These restrictions also apply to immediate household members of Entrant or prize winners.
- d. To claim a prize, the Qualifying Prize Winners and Grand Prize Winner must provide valid government-issued photo identification and provide their complete address, date of birth, email address and phone number, and Social Security Number.
- e. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any Entrant who does not meet the eligibility requirements and will also delete any entry as required by law.
- f. This Contest is subject to all applicable federal, state and local laws and regulations. By participating and/or acceptance of prize(s), Entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

### 3. PRIZES

- a. Five (5) qualifying prizes will be awarded. Each qualifying prize consists of one (1) VISA gift card. The gift cards will be subject to the terms and conditions as set forth by the issuer of the gift cards. The gift cards will bear no expiration dates. The Approximate Retail Value ("ARV") of the qualifying prize is \$100.00. Transportation costs are excluded in the given price. The Qualifying Prize Winners will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the qualifying prize(s).

The gift cards are valid only on the date(s) printed on the gift cards, and they are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for cash or credit at any time, nor will they be replaced if lost or stolen.

- b. One (1) grand prize will be awarded in the Contest. The grand prize consists of the following: one (1) Apple iPad Air – A12 Chip - 256G. The ARV of the grand prize is \$673.00.
- c. All prizes are awarded "as is" and the station does not make (and is not responsible for) any representations, guarantees, or warranties of any kind, express or implied, in fact or in law, relating to any prize (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose), and all such warranties are hereby disclaimed.
- d. If a prize is unable to be awarded for reasons such as unavailability due to the closure of Contest Sponsor's locations or weather, disease, epidemic, pandemic, national or regional emergency, or for any reason beyond the control of the Station or Contest Sponsor, their sole responsibility to the Qualifying Prize Winners and Grand Prize Winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s).
- e. As indicated above, all sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the Qualifying Prize Winners and Grand Prize Winner. Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station is not responsible for replacing tickets in the event of show cancellations as a result of weather, or promoter, or performer actions. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.
- f. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management and Contest Sponsor with respect to the Contest are final.

- b. Five (5) Qualifying Prize Winners will be selected in the Contest during the following periods of time (“Drawing Periods”):

  - One (1) Qualifying Prize Winner will be selected on Wednesday, September 9, 2020 at approximately 9:00 a.m. (PDT) in a random drawing of all eligible text and online entries received between 6:50 a.m. (PDT) and 7:50 a.m. (PDT) on Tuesday, September 8, 2020.
  - One (1) Qualifying Prize Winner will be selected on Thursday, September 10, 2020 at approximately 9:00 a.m. (PDT) in a random drawing of all eligible text and online entries received between 6:50 a.m. (PDT) and 7:50 a.m. (PDT) on Wednesday, September 9, 2020.
  - One (1) Qualifying Prize Winner will be selected on Friday, September 11, 2020 at approximately 9:00 a.m. (PDT) in a random drawing of all eligible text and online entries received between 6:50 a.m. (PDT) and 7:50 a.m. (PDT) on Thursday, September 10, 2020.
  - One (1) Qualifying Prize Winner will be selected on Monday, September 14, 2020 at approximately 9:00 a.m. (PDT) in a random drawing of all eligible text and online entries received between 6:50 a.m. (PDT) and 7:50 a.m. (PDT) on Friday, September 11, 2020.
  - One (1) Grand Prize Winner will be selected on Monday, September 14, 2020 at approximately 9:00 a.m. (PDT) in a random drawing of all Qualifying Prize Winners chosen from Monday, September 7, 2020 and Friday, September 11, 2020.
- c. Odds of winning the qualifying prize depends upon the number of eligible text message or online entries received with the correct Keyword during the applicable Drawing Period. Odds of winning the grand prize is one (1) in five (5).
- d. Qualifying Prize Winners and Grand Prize Winner must listen to the Station to win but do not need to be present to win. All prizes must be picked up or claimed within thirty (30) days of winning, as directed by the Station, including in-person, if public health conditions permit, at the office of the Station located at 280 Commerce Circle, Sacramento, CA 96815 between regular business hours of 8:00 a.m. (PT) to 5:00 p.m. (PT), Monday through Friday. If public health conditions do not permit a Qualifying Prize Winner or Grand Prize Winner to claim the prize in person within thirty (30) days, the Station will coordinate with the Qualifying Prize Winner or Grand Prize Winner to confirm their identify remotely and to deliver the prize by mail or other means of delivery. If the Qualifying Prize Winner or Grand Prize Winner chooses to have a prize shipped, the Qualifying Prize Winner or Grand

Prize Winner will be required to sign a release that the Station and any Released Parties (defined below) are not responsible if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping. In such cases, there is no purchase necessary to enter or win, except for reasonable postage and handling fees the amount of which shall not exceed \$1.50 plus the actual cost of postage to ship the prize.

- e. Potential Qualifying Prize Winners and Grand Prize Winner will be notified of winning by telephone at the time of the drawing. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. Upon notification or notification attempt, the potential Qualifying Prize Winners and Grand Prize Winner will be required to respond to such notification attempt and must execute and return an IRS Form W-9, affidavit of acceptance, eligibility, liability, publicity release, and if applicable, Contest Sponsor liability release forms within thirty (30) days of such notification or notification attempt of prize(s) will be forfeited. ## 5. CONDITIONS

- a. Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins or any other methods may void that Entrant's entries and that Entrant may be disqualified. The use of any device to automate multiple entries is prohibited. Any use of robotic, repetitive, automatic, programmed, or similar entry methods or agents (including, but not limited to, promotion entry services or proxies) will void all entries by that Entrant at the Station's discretion. The Station's computer or telephone system is the official time keeping device for this Contest. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address; or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an Entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good-faith determination that an Entrant has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that Entrant from entering and/or winning this

and any or all future Station-administered contests and seek damages to the fullest extent permitted by law.

- b. The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the Contest, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. To the extent the Station makes material changes to the terms and conditions of the Contest, any such material changes will be broadcast on the Station and/or posted on its website: now100fm.com within twenty-four (24) hours of the change and periodically thereafter. If due to circumstances beyond the control of the Station, any Contest Sponsor location is closed, or competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled due to weather, natural disasters, disease, epidemic, pandemic, national or regional emergency, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the Contest and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.
- c. Calling the Station regarding the Contest constitutes permission for the Station to tape the caller's voice and use it on the air. All telephone calls during the Contest may be taped without further permission from the caller. By entering the Contest and/or acceptance of prize(s), all Entrants consent to the use of their name, photograph, likeness, biography, voice, video, entry materials, prize information (if any), or any statements made for trade, publicity, advertising, or promotional purposes, in any and all media, now known or hereafter devised, including online announcements, without limitation and without compensation, except where prohibited by law.
- d. Each Qualifying Prize Winner and Grand Prize Winner will be required to produce identification satisfactory to the Station. For example, Qualifying Prize Winners and Grand Prize Winner will be required to sign an IRS Form W-9, affidavit of eligibility and release, including a publicity release, as prepared by the Station prior to receiving their prize. Each Qualifying Prize Winner and Grand Prize Winner will solely be responsible for any (federal, state, or local) taxes or fees that result from the receipt and/or use of their prize and may receive an IRS Form 1099-Misc for all prizes won from the Station in any calendar year where the aggregate value of all such prizes is \$600 or more. - a. - a. In the event of conflict between the Station's Terms of Use Agreement and these Official Rules, the terms of these Official Rules shall apply. Any information that Twitter, Facebook, or Instagram collects through an entry in the Contest may be subject to Twitter's, Facebook's, or Instagram's own terms and policies.

## 7. WINNERS' LIST/COPY OF OFFICIAL RULES

- a. Any violation of these rules will result in disqualification. Consistent with Section 1(e), only one (1) entry per Entrant is permitted regardless of the method of entry. Any attempt by any one or more Entrants to obtain more than one (1) entry by using the same email address, Twitter, Facebook, or Instagram account or similar registration method through any means including, without limitation, multiple/different email addresses, Twitter, Facebook, or Instagram accounts, identities, registrations, logins or other methods will void all entries from that address or account, and such Entrant(s) will be disqualified.
