 - i. To enter via text message, listen to the Station each weekday beginning on Monday, July 29, 2024 at 8AM PST-9AM PST, 12PM PST-1PM PST, 3PM PST-4PM PST, & 5PM PST-6PM PST and ending on Friday, August 2, 2024 at 8AM PST-9AM PST, 12PM PST-1PM PST, 3PM PST-4PM PST, & 5PM PST-6PM PST during these dates for the on-air personality to announce the cue to text. Upon hearing the cue to text, listeners must text the Keyword announced on-air to 1-916-866-1005 within the time period specified to enter the Contest. Only one entry per Keyword per person is permitted. By texting to enter the Contest, the listener consents to receive automated messages about the Contest on his or her cell phone. Standard message and data rates may apply. The frequency of automated message(s) that an individual may receive after entering the Contest may vary. If an individual wishes to stop receiving text messages, he or she can text STOP to cancel such messages.
