- b. To enter the Contest, entrant may enter by text message or online beginning on Monday, October 7, 2024, at 8:05AM PST-9:05 AM PST, 9:05 AM PST-10:05AM PST, 10:05AM PST-11:05 AM PST, 11:05AM PST-12:05PM PST, 12:05PM PST-1:05PM PST, 1:05PM PST- 2:05PM PST, 2:05PM PST- 3:05PM PST, 3:05PM PST- 4:05PM PST, and 4:05PM PST- 5:05PM PST, and ending on Friday, October 18, 2024 at 8:05AM PST-9:05 AM PST, 9:05 AM PST-10:05AM PST, 10:05AM PST-11:05 AM PST, 11:05AM PST-12:05PM PST, 12:05PM PST-1:05PM PST, 1:05PM PST- 2:05PM PST, 2:05PM PST- 3:05PM PST, 3:05PM PST- 4:05PM PST, and 4:05PM PST- 5:05PM PST ("Entry Period").
 - i. To enter via text message, listen to the Station each weekday beginning on Monday, October 7, 2024, 8:05AM PST-9:05 AM PST, 9:05 AM PST-10:05AM PST, 10:05AM PST-11:05 AM PST, 11:05AM PST-12:05PM PST, 12:05PM PST-1:05PM PST, 1:05PM PST- 2:05PM PST, 2:05PM PST-3:05PM PST, 3:05PM PST- 4:05PM PST, and 4:05PM PST- 5:05PM PST until the end of the contest at 4:05PM PST- 5:05PM PST on Friday, October 18, 2024, during these dates for the on-air personality to announce the cue to text. Upon hearing the cue to text, listeners must text the Keyword announced on-air to 1-916-866-1005 within the time period specified to enter the Contest. Only one entry per Keyword per person is permitted. By texting to enter the Contest, the listener consents to receive automated messages about the Contest on his or her cell phone. Standard message and data

rates may apply. The frequency of automated message(s) that an individual may receive after entering the Contest may vary. If an individual wishes to stop receiving text messages, he or she can text STOP to cancel such messages.

Terms are available at the Station's Terms of Use. Station assumes no responsibility for charges incurred for text messaging, including, without limitation, any text messages or Contest notices from the Station. To be eligible to win, entrants in the Contest must provide all information requested including entrant's full name, complete address (including zip code), email address, day and evening phone numbers, and date of birth to verify eligibility. P.O. Boxes are not permitted as addresses.

Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. - c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.
- e. Only one (1) entry per person is permitted regardless of the method of entry. There will be up to a total of ten (10) winner(s) selected in the Contest.
- f. All text message and online entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of California, eighteen (18) years of age or older, and who reside in the Sacramento

Metropolitan area as defined by Nielsen; this includes Yolo, Sacramento, Sutter, Nevada, Placer, and El Dorado Counties. Void where prohibited or restricted by law.

- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s).
