- b. To enter the Contest, entrant may enter by text message or online beginning on Monday, December 9, 2024 at 7:30AM PST-9AM PST, 11:30AM PST-1PM PST, 2:30PM PST-4PM PST, and 4:30PM PST-6PM PST and ending on Friday, December 13, 2024 at 7:30AM PST-9AM PST, 11:30AM PST-1PM PST, 2:30PM PST-4PM PST, and 4:30PM PST-6PM PST ("Entry Period").
  - i. To enter via text message, listen to the Station each weekday beginning on Monday, December 9, 2024 at 8AM PST-9AM PST, 12PM PST-1PM PST, 3PM PST-4PM PST, & 5PM PST-6PM PST and ending on Friday, December 13, 2024 at 8AM PST-9AM PST, 12PM PST-1PM PST, 3PM PST-4PM PST, & 5PM PST-6PM PST during these dates for the on-air personality to announce the cue to text. Upon hearing the cue to text, listeners must text the Keyword announced on-air to 1-916-866-1005 within the time period specified to enter the Contest. Only one entry per Keyword per person is permitted. By texting to enter the Contest, the listener consents to receive automated messages about the Contest on his or her cell phone. Standard message and data rates may apply. The frequency of automated message(s) that an individual may receive after entering the Contest may vary. If an individual wishes to stop receiving text messages, he or she can text STOP to cancel such messages.

Station assumes no responsibility for charges incurred for text messaging, including, without limitation, any text messages or Contest notices from the Station. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator. Online entrants will also be required to listen to the Station during the times listed above for the Keyword and short code and must submit them in the online entry form.
- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.

The Contest is open to all persons who are legal U.S. residents of the state of California, eighteen (18) years of age or older, and who reside in the Sacramento Metropolitan area as defined by Nielsen; this includes Yolo, Sacramento, Sutter, Nevada, Placer, and El Dorado Counties. Void where prohibited or restricted by law.

- b.
